- 1. <u>Call to Order:</u> The meeting was called to order by Chair Paul Richard at 9:00 a.m. The following members of the Ethics Commission were also present: Vice Chair Dave Anderson, Commissioners Ward Koeser, Ron Goodman, and Cynthia Lindquist, as well as Executive Director Rebecca Binstock, General Counsel Logan Carpenter, and Executive Assistant Alisha Maier. - 2. <u>Discussion of Advisory Opinion Request No. 23-03, dated September 25, 2023:</u> Chair Richard advised the Commission that ED Binstock, GC Carpenter, and himself went back and reviewed the original advisory opinion request since the previous meetings discussion and found a procedural issue regarding whether the Commission should issue an opinion.
